Soil extractable P analysis

For soil extractable P analysis (only), Scheme Applicants and Scheme Members may rely upon analysis provided by third parties (e.g. farmers and agronomists); so long as they are satisfied with the source data e.g. have been provided with evidence of testing. In this scenario (of third party data provision) the analysis does not have to be provided by an ABL approved laboratory.
