#### Soil extractable P analysis

Until the 1<sup>st</sup> January 2020, Scheme Applicants and Scheme Members may rely upon soil extractable P analysis (only) provided by third parties (e.g. farmers and agronomists); so long as they are satisfied with the source data (e.g. have been provided with evidence of testing). In this scenario (of third-party data provision) the analysis does not have to be provided by an ABL approved laboratory.
