## 3. Privacy policy

#### 3.1. Policy

Assured Biosolids Limited are committed to protecting and respecting your privacy.

This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. #### 3.2. How do we collect information?

## 3.3.1. Personal information

## 3.3.2. Website data

Our online forms that may collect personal data are protected by encryption. We use appropriate technological and organisational measures to safeguard personal information that is disclosed to us and keep it secure, accurate and up to date.

If there are any suspected data security breaches, we will notify relevant parties and any applicable regulator of a suspected data security breach where we are legally required to do so.

While we will use all reasonable efforts to secure your personal data, in using the website you acknowledge that the use of the internet is not entirely secure and for this reason we cannot guarantee the security or integrity of any personal data that is transferred via the internet. ## What is a cookie?
